The international strategy of the University of Social and Medical Sciences in Warsaw (Uczelnia Społeczno-Medyczna w Warszawie) (old name: Wyższa Szkoła Przedsiębiorczości w Warszawie) aims to strengthen its position with respect to both education and research at the international arena. The USM in Warsaw aspire to be a relevant player among local society and industry, inspiring students and staff to gain international competences. The strategic goals of USM are:

- international collaboration with partners and foreign institutions in terms of research and professional traineeships;
- enhancing educational offer providing courses in foreign languages;
- establishing exchanges of recognized professionals and teachers to provide highly specialized classes for students and staff:
- organizing joint conferences and meetings with international partners, as well as international publishing of research and didactic works, including monographs, scientific journals, etc.;
- providing effective mechanism to recruit prospective incoming students from European countries, as well as from some other non-EU countries;

USM has fully implemented the European Credit Transfer and Accumulation System and the credit system and methodology is based on the ECTS and Bologna process principles. ECTS credit points are a numerical value assigned to individual items based on the total average student workload required to achieve for the assumed learning outcomes – per academic year 60 ECTS (per academic semester 30 ECTS). The student gets points for passing the subject, regardless of the value of positive (passing) grade received. When a subject is not passed by a student no ECTS points are granted. Credits can be allocated to project work, papers and practical placements, as well. The rules for assigning points to specific subjects are determined by the University, taking into account the requirements set out in the resolution of the Senate, regarding guidelines for adoption of study plans and curricula being approved by the National Accreditation Agency.

ECTS credits are awarded to all students: both students at USM and students coming from other universities, to pursue a part of the education program at University of Entrepreneurship in Warsaw. Incoming and outbounding students define their study plan at the host university together with the Dean / person responsible at the faculty and signed in the Learning / Training Agreements. After passing exams - at the end of each semester study, each student receives transcript of records at host university, which is then recognised at home institution by using ECTS equivalences. During implementation of the E+ mobility projects, USM will work out tables for conversion of grades based on grade distribution tables from reference foreign universities (different national grading systems)

Students coming from study or traineeship abroad will obtain full recognition for the completed programme (prepared and accepted by the Dean before they left for the study/ traineeship abroad).

Any attempt to modify the content will lead to a break of the integrity of the electronic signature, which can be verified at any time by clicking on the eReceipt validation symbol.
